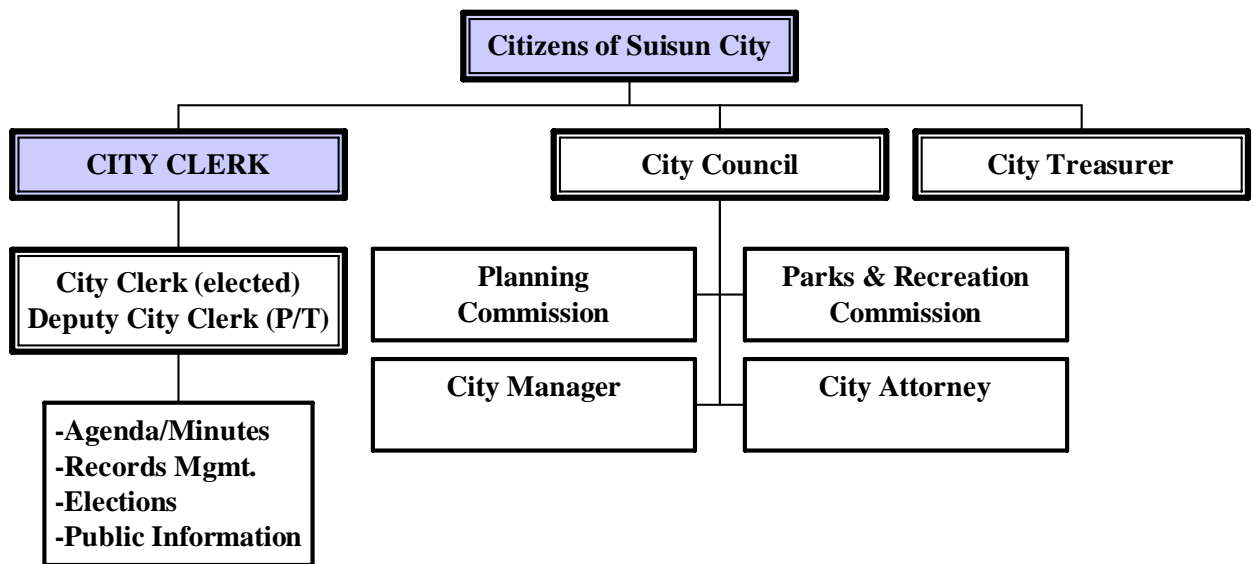


## CITY CLERK

The City Clerk is a historical and State-mandated role, serving as the custodian of the City Seal and the legal records for the municipal organization.
